Just as at our in-person meetings, if you wish to speak, you need to state your Name and Post Number so that we know who is speaking.

You have 2 options: call in (audio only) or Video.

If this is first conference call, then follow these directions to set up the app:

- 1. Click on this link to go directly to the FreeConferenceCall downloads page: https://www.freeconferencecall.com/downloads-2 or copy and paste. Select which version you would like to install on your computer..
- 2. Open the program once it downloads, and select "Join."
- 3. Enter your First Name, Last Name, and E-mail in the boxes provided, and enter stevefalk in the box labeled Online Meeting ID.
- 4. Then, click the "Join" button.
- 5. Join the audio portion of the meeting by clicking on the "Computer Audio" button.
- 6. To display your video feed, click the "Video" button on the lower left portion of the pop-up screen.
- 7. You should mute your phone or computer (mute button is on the lower left) at all times except when you wish to speak. Also, do not have anything in the background (TV, radio, music, etc) when you wish to speak. Failure to mute will cause feedback and a difficulty for others to be heard. Should you fail to remember to mute your microphone when not speaking, the online administrator may mute your microphone for you.

There are also apps you can download for your phone or tablet in the Google Play or Apple App Stores, if you prefer.

## FROM THE DEPARTMENT COMMANDER

"Four score and seven years ago our fathers brought forth on this continent, a new nation, conceived in liberty, and dedicated to the proposition that all men are created equal." Sound familiar? It should – it was the beginning of Abraham Lincoln's Gettysburg Address delivered on November 19, 1863. That was 87 years after the founding of this great nation.

It is now almost two and a half centuries since the founders dedicated their fortunes and their lives to create a free nation. During that time, we endured many trials, yet here we are – the most free and secure nation on the face of the earth.

Were our founders perfect? No. That is why we have 27 amendments to our constitution. Did you know that over 11,000 amendments have been proposed? However, our founders were intelligent and worked to create the greatest nation on earth. A nation that all of us have at one time or another, just as the founders, been willing to give our lives for – some in uniform and others while fighting to right a wrong.

Did the founders agree on everything? No. They fought bitterly over many issues, but in the end, they came together for the good of the new nation.

Today we are embroiled in our own fight of national survival. Did you know that there are 7 people running for President? We tend to focus only on the 2 primary candidates. These 2 are different as day and night. Both campaigns accuse the other of being racist. Both claim they can run the country better than the other. Both claim their ideas are better than the other. Which is right? That is for you to decide.

The most important thing our founders gave us was the right to vote. It is alarming how few Americans exercise that right. In 2016 only 58.1% of eligible voters bothered to vote, but many of the other approximately 42% continue to complain about the candidates who won.

We members of the Jewish War Veterans, whether regular members, in service members, life members. or Patrons, all have our views of the candidates. Some are strong – some of us are probably in that 42% who did not bother to vote in the last election and will not vote this time. There however are 2 guiding principles within the JWV that we must adhere to: that we respect the opinion and position of our fellow members and that we leave politics out of what we do.

We are all members for two primary reasons: to be with other Jews who share our backgrounds and our desire to help our fellow veterans. Politics have no place in that.

I am asking that all members of this Department, as well as the entire JWV, refrain from making comments about political

#### Quarterly Meeting to Feature Special COVID-19 and Stroke Update

Come and join us (virtually) at our Department Quarterly Meeting on Sunday, October 25<sup>th</sup> when we are pleased to invite Dr. Charles Sand to speak about the ongoing COVID-19 pandemic issues throughout Florida as well as providing important information that everyone should know regarding signs, symptoms and treatment of strokes.

Dr. Sand currently serves as an advisor on numerous state and local COVID-related advisory committees and communicates directly with the CDC and other governmental agencies regarding the latest updates on the pandemic and treatments.

In the field of stroke care, Dr. Sand is a pioneer in setting protocols to standardize and optimize stroke care. He regularly both advises and teaches the stroke protocols to physicians, nurses, EMS personnel and laypeople. He is the founder and Chair of the Hillsborough County Emergency Medical Planning Sub-Committee on STEMI (Stroke Evaluation and MI [Heart Attack]). He played an integral role in Florida becoming the first state in the nation to pass a law to optimize stroke care. He is also the co-founder of St. Joseph's Hospital's Stroke Program.

Among his many professional designations, he is double board certified in Emergency and Internal Medicine. He was the National Faculty Chair of the American Heart Association's Advanced Cardiac Life Support (ACLS) course. Dr. Sand has also taught Advanced Trauma Life Support (ATLS) to community and trauma center physicians. He has co-authored numerous articles and medical texts, including on ACLS and was a conributing editor of a 2001 ACLS book used by all hospitals and EMS Providers for Acute Cardiac and Stroke Care Guidelines.

In addition to all of the above, Dr. Sand was instrumental in making Florida the first state in the nation to pass an AED layperson law, resulting in the placement of more than 12,000 AEDs throughout Florida for layperson use. If it weren't for Dr. Sand, there would be no AEDs placed at all Florida State high school athletic tournaments, there would be no AEDs in Sheriff vehicles, county public schools or numerous large business throughout West Central Florida.

Dr. Sand was named one of the "Heroes of Emergency Medicine" by the American College of Emergency Physicians and the "National Stroke Advocate of the Year" by the National Stroke Council. He was recognized by Tampa Bay Metro Magazine as a Community Leader in Cardiovascular Disease.

He was part of the Hurricane Andrew Disaster Medical Assistance Team in 1992. From 1991-1994, he served as a NASA Space Shuttle Program Physician. We are honored to have Dr. Sand take time out of his busy schedule to provide these important updates.

issues and I am asking our National Commander to issue a statement to this effect. Openly making statements that are political in nature can destroy this organization. Public statements on behalf of the JWV should not be made if it concerns a political issue, no matter how strongly one may feel about the issue. We need to remain an apolitical organization.

Some members have expressed to me their concern about the voting process, that one candidate or the other is trying to steal the election. I personally believe the system is set so that cannot happen. I feel every American should either go to their polling place and vote or request an absentee ballot and submit it in a timely fashion. I do not believe ballots should be sent to all registered voters blindly. It is a fact that in every state there are people on the voting rolls who are dead or no longer living at the address they have registered. This can allow anyone to submit a ballot in the name of someone else.

Both primary candidates have told us this is the most important election of our lives. In some ways they are right, considering how different their ideas are. You must decide for yourself which you believe is the best way to go. All I ask is that you take an honest look at the issues and positions, forget about your personal feeling of the candidates or party allegiance, and make an intelligent decision for the good of our great nation.

The most important thing any of us can do is vote. No matter who you vote for, be sure to vote. And have faith in the system. Welcome to the Jewish New Year 5781. May it bring all of us peace and good health.

990N: Sent to IRS with copy to National Attn: Harrison Heller by May 1st along with the Financial Board Report.

**Fidelity Bond:** Bill is sent by National to Post in December and payment is due by **February**. Send to National Attn: Christy Turner.

**Liability Insurance:** Can be purchased through National or separately and proof of insurance should be sent at the same time as the Financial Board Report by **May 1**<sup>st</sup> to National Attn: Christy Turner.

**Dues update:** is sent to posts and departments between April and June and needs to be returned before **July 1**st when dues are set for the year. Send to national Attn: Harrison Heller.

**Membership Updates:** Should be sent as they occur to the National Membership Department, Department Adjutant, and Department Commander and should include address, phone, and email updates; deaths; transfers; and post contact information.

**Delegate form for National Convention:** Sent to each post between May and June and needs to be returned to National Membership Department at least 15 days prior to the National Convention. Each post gets 1 delegate for every 10 members who are current on their dues status. Copy should be sent to Department Commander and Adjutant.

Report of Convention Form: Department submit to National Attn: Harrison Heller not later than 15 days prior to convention.

#### Telling the Story of the **Jewish American Warrior**





Chartered by an act of Congress in 1958, the National Museum of American Jewish Military History, under the auspices of the Jewish War Veterans of the U.S.A., documents and preserves the contributions of Jewish Americans to the peace and freedom of the United States, educates the public concerning the courage, heroism and sacrifices made by Jewish Americans who served in the armed forces, and works to combat anti-Semitism.

The purpose of the Museum is to preserve a record of the patriotic contributions of the men and women of the Jewish faith who served during and between times of

war in the Armed Forces of the United States and as veterans thereof, from the time of the founding of this country to the present, for future generations by illustration through public education utilizing the Museum's collections for exhibits, publications, and educational programs.

The Museum was founded in 1958 by a group of Jewish War Veterans, who saw the value in telling the story of American Jewish Warriors. It is located at 1811 R Street NW, in the historic Dupont Circle area, and it is near the Dupont Circle Metro Station, as well as having a Capital Bikeshare station directly in front of the museum.

The Museum is open Monday through Friday 9-5, Sundays by appointment, and admission is free. If you wish to schedule a group tour, please call 202-265-6280 or email nmajmh@hmajmh.org. Membership information is below and also available at nmajmh.org.

#### HISTORICAL EVENTS CALENDAR

October 1: 1938 - Hitler's troops occupied the Sudetenland portion of Czechoslovakia.

1946 - Twelve Nazi leaders were sentenced to death at the International War Crimes Tribunal in Nuremberg, Germany.

1949 - The People's Republic of China was founded with Mao Zedong as Chairman.

1979 - After 70 years of American control, the Panama Canal Zone was formally handed over to Panama.

October 2: 1967 - Thurgood Marshall was sworn in as the first African American associate justice of the U.S. Supreme Court.

1975 - Japanese Emperor Hirohito made his first-ever visit to the White House.

October 3: 1863 – Pres. Abraham Lincoln issued a proclamation designating the last Thursday in November as Thanksgiving Day.

1990 - After 45 years of Cold War division, East and West Germany were reunited as the Federal Republic of Germany.

October 4: 1957 - The Space Age began as the Russians launched the first satellite into orbit. Sputnik I weighed just 184 lbs.

October 6: 1949 - "Tokyo Rose" (Iva Toguri d'Aquino) was sentenced to 10 years imprisonment and fined \$10,000 for treason.

1973 - The Yom Kippur War started as Egypt and Syria launched attacks on Israeli positions.

1981 - Egyptian President Anwar Sadat was assassinated in Cairo by Muslim fundamentalists.

October 7: 1985 - Palestinian terrorists seized the Italian ship Achille Lauro; an elderly wheelchair-bound American, was murdered.

October 8: 1996 - Palestinian President Yasser Arafat made his first visit to Israel for talks with Israeli President Ezer Weizman.

October 10: 1954 - Ho Chi Minh entered Hanoi, Vietnam, after the withdrawal of French troops.

October 12: 1960 - In the United Nations, Soviet leader Nikita Khrushchev took off his shoe and pounded his desk.

October 13: 1775 - The United States Navy was born, authorized by the Second Continental Congress.

1792 - The cornerstone of the White House was laid by George Washington.

1943 - Italy declared war on its former Axis partner Germany after the downfall of Mussolini.

October 14: 1947 - U.S. Air Force Captain Chuck Yeager became the first man to break the sound barrier.

October 17-25: 1944 -The Battle of Leyte Gulf, off the Philippine Islands, the largest naval battle in history during WWII

October 18: 1945: The Nuremberg War Crimes Trial began

October 23: 1983 - Terrorists drove a truck loaded with TNT into the U.S. and French headquarters in Beirut killing 299.

October 24: 1945 - The United Nations was founded.

October 25-30: 1983 - The Caribbean island of Grenada was invaded by the U.S. to restore "order and democracy."

October 28: 1886 - The Statue of Liberty was dedicated on Bedloe's Island in New York Harbor.

1919 - Prohibition began in the U.S.

1962 - The Cuban Missile Crisis ended

October 29: 1929 - The stock market crashed as over 16 million shares were dumped amid tumbling prices.

November 4: 1979 - Young Iranian militants stormed the U.S. Embassy in Teheran, taking 90 hostages, including 52 Americans.

1995 - Israeli Prime Minister Yitzhak Rabin was assassinated as he left a peace rally in Tel Aviv.

November 8: 1939 - An assassination attempt on Hitler failed at the Buergerbraukeller in Munich.

November 9: 1989 - The Berlin Wall was opened up after standing for 28 years as a symbol of the Cold War.

**November 10: 1775 -** The U.S. Marine Corps was established as part of the U.S. Navy.

November 11: 1954 - Celebrated in the U.S. as Veterans Day after Congress changed the word Armistice to Veterans.

1938 - Irving Berlin's God Bless America was first performed.

1972 – Official end to the Vietnam War as the U.S. turned over its military base at Long Binh to the South Vietnamese.

1973 - Egypt and Israel signed a cease-fire agreement sponsored by the U.S.

November 13: 1942 - The 5 Sullivan Brothers from Iowa, were lost in the sinking of the cruiser USS Juneau.

**November 15: 1777 - The Articles of Confederation were adopted by Continental** Congress.

November 17: 1800 - The U.S. Congress met for the first time in the new capital at Washington, D.C. President John Adams then became the first occupant of the Executive Mansion, later renamed the White House.

1869 - The Suez Canal was formally opened after more than 10 years of construction.

November 19: 1863 - President Abraham Lincoln delivered the Gettysburg Address.

November 20: 1945 - The Nuremberg War Crime Trials began

November 22: 1963 - At 12:30 p.m President John F. Kennedy was assassinated in downtown Dallas.

November 26: 1789 - President George Washington proclaimed the first American holiday to be Thanksgiving Day,

November 29: 1947 - U.N. General Assembly partitioned Palestine, establishing the Jewish state of Israel in 1948.

**November 30: 1782 - America's War of Independence ended with a provisional** peace treaty.

December 1: 1955 - Birth of the modern American civil rights movement as Rosa Parks was arrested in Montgomery, AL.

December 6: 1865 - The 13th Amendment to the U.S. Constitution was ratified abolishing slavery.

December 7: 1941 – Attack on the Pearl Harbor by 200 Japanese aircraft, leaving nearly 3,000 Americans dead.

December 8: 1941 - A day after the Japanese attack on Pearl Harbor, the United

States and Britain declared war on Japan.

1991 - The USSR (Union of Soviet Socialist Republics) ceased to exist, December 14:

1799 - George Washington died at Mount Vernon.

1911 - Norwegian explorer Roald Amundsen became the first person to reach the South Pole.

December 15:

1791 - The Bill of Rights (first 10 amendments to the U.S. Constitution) became effective.

1961 - Nazi SS-Colonel Adolf Eichmann was sentenced to death in Jerusalem

December 16: 1773 - The Boston Tea Party occurred

1944 - During World War II in Europe, the Battle of the Bulge began

1991 - The United Nations revoked Resolution 3379, approved in 1975, which had equated Zionism with racism.

December 17: 1903 - Orville and Wilbur Wright achieved the first powered, controlled airplane flights.

December 19: 1946 - War broke out in French Indochina as Ho Chi Minh attacked the French seeking to oust them from Vietnam.

December 20: 1989 - The U.S. invaded Panama attempting to capture Manuel Noriega

December 21: 1945 - World War II General George Patton died in Germany following a car accident.

1972 - East and West Germany established diplomatic ties,

1993 - The KGB (Soviet Secret Police) organization was abolished by Russian President Boris Yeltsin.

December 23: 1913 - The U.S. Congress passed the Federal Reserve Act

December 24: 1943 – Gen. Dwight D. Eisenhower was appointed Supreme Commander of the Allied Expeditionary Force.

December 30: 1993 - Israel and the Vatican agreed on mutual recognition, ending 2,000 years of unfriendly relations
